	 Assist locally owned & operated businesses to access funding, training & development programs available through non-profit organizations
	Support community interests for individuals as well as businesses
	 Present a united front to other organizations for accomplishing mutually beneficial objectives Through fund-raising efforts and grants available to non-profits, generate income to facilitate the projects the organization agrees to pursue
3.	Historic Review of Twin Lakes Improvement Association
	• Due to the previous organization not having achieved a 501(c)(3) legal status, and because it had lay dormant for a number of years, it was agreed to form a new citizens' organization to accomplish goals related to improving the quality of the town and community
4.	Advantages of 501(c)(3) type organization
	 Having the 501(c)(3) designation allows the organization to apply for and receive a number of grants and assistant programs which otherwise would be out of reach
	• It was suggested we borrow structure and by-laws from local existing 501(c)(3)s serving similar purposes. See action items below for further details
5.	Decide upon a name for the organization
	 Kendra suggested the name: "Friends of Twin Lakes" because it left a lot of latitude for adjusting to changing conditions & requirements over time
