\$100. This provides basic membership in the LCEDC, invitation to all meetings, use of all LCEDC resources, and inclusion on the LCEDC correspondence list.

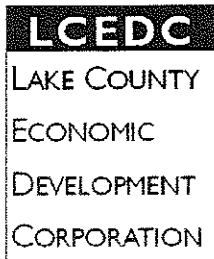
