Status of funds. REMINDER: No construction garbage, furniture or bedding--just normal household garbage--\$5 per garden bag or \$5 for 2 kitchen bags--honor system.) <u>Designated Account balances</u>: We have a new designated account for Dexter Cabin Maintenance/Preservation established at the request of Charlie Fitzsimmons' family following his passing. \$275 balance; Heritage Park \$2,183; Fire Station 2 balance \$21,918 (We also received a \$3,000 gift card from Lowes and LT 100 is supposed to give us \$3,500 based upon a grant award for appliances last year, but they're waiting until we have the FS2 building.)
