DRAFT-- Friends of Twin Lakes Annual Member Meeting –DRAFT

July 22, 2023

The meeting was called to order at 9:00 am as a hybrid meeting both in person at the schoolhouse and by zoom via Zoom.

Board of Directors <u>Present:</u> Kelley Sweeney, President; Colleen Schweigert, Vice President/Treasurer; Beth Manning, Secretary; Anne Bond, and Jeanine Ravencraft on Zoom.

The meeting began with Lake County's Office of Emergency Management Director Claire Skeen. Claire informed the members that we need to engage in emergency planning for the safety of the community.

- Claire left two flyers in the back of the room for all FOTL members. One concerns fire restriction levels, the other is how Lake County can reach you in case of emergency, Local Emergency Alerts.
- Potential Tabletop for Neighborhoods: Best time suggested was September non-football weekend.
 Members were interested in evacuation routes, go bags, and how long they would need to plan to be away.
- Claire has made a proposal to the County to acquire Zonehaven, an evacuation management software. The software can coordinate all aspects of an evacuation. Information by neighborhoods throughout the state.
- Update on Crisis Track, a State gift to all counties. More of a damage assessment and a survivor support tool. You can register as an incident survivor and list needs.
- Hazard mitigation plan. Lists all hazards. Must be updated every 5 years. She will plan to have community meetings to discuss issues.
- Firestation II will not be an evacuation center but rather a command center.

- Friends of Lake County has 2 upcoming work days that are changing from August 26 and 27 to a date to be announced in September. It will involve Black Cloud Trailhead Fence and Kiosk Installation.
- Public Works/Road and Bridge will be working on north side of CR 10 to continue chip seal treatment resuming first week of August. They are applying recycled asphalt.

• It will be up to the Colorado State Foresters to decide which day of the 2 they want to come here.

Fire mitigation matters! Defensible space is the natural and landscaped area around your home that has been modified to reduce wildfire hazard. By creating a defensible zone, your home and property are less vulnerable and the chance of spreading wildfire is greatly reduced.

- CSF will send out several foresters and an industrial chipper from Salida to help in this project.
- Those who register will be charged in 15 minute increments at \$50 per 15 minutes to cover gas and workers.
 - o Based upon past events, most piles were done in 15 to 30 minutes. You will be required to sign an agreement for entry and to reimburse FOTL.
 - o Similar to years past, Kelly Sweeney will be there to assist in hustling slash and tracking time, as well as collecting payments from those whose slash was chipped.
